The river landscape Mura Drava Danube (TBR MDD) is connecting 12 protected areas and uniting 5 countries along 3 rivers into first world pentalateral biosphere reserve. The future UNESCO biosphere reserve known as Amazon of Europe (AoE) represents the largest and most preserved free-flowing river system in Central Europe. Valuable natural beauty, endangered habitats and diverse cultural traditions have enormous potential for sustainable tourism, while underdeveloped border regions face lack of capacities, unemployment and emigration.

DTP project AoE Bike Trail is the first fivecountry development project in TBR MDD, connecting key stakeholders into one linear biking product. The results (network, booking system, valorisation programme) will be substantially upgraded with this project into truly responsible destination AoE, by developing much-needed joint strategies, IT solutions and learning interactions at significantly broader destination level for an even better tourist experience in the area of these mighty rivers!

Project aim is to enhance sustainable economic growth and tourism development based on distinctive natural and cultural heritage, which will enhance the cooperation between the regions and enabling environment for high-quality tourism, responding to limited resources of ecosystems.

With the project Responsible Green Destination Amazon of Europe, partners will follow specific objectives:

1. Stimulate environmentally friendly **behaviour in tourism sector -** development and testing of the Responsible Green Destination Tourism Impact Model (RGD TIM model), which will form the basis for establishing the transboundary destination Amazon of Europe. It will combine latest

2. Develop an integrated solution for managing sustainable tourism - the integrated solution for managing sustainable tourism in AoE, which will represent a model approach how to plan tourism development in biosphere reserves to enable nature-friendly, high quality experience for the visitors who are actively seeking out authentic nature, cultural, and adventure experiences in unspoiled destinations while preserving the nature as most valuable assets of the area.

3. Improve capacities for responsible green tourism - building of capacities of key stakeholders in all participating regions and sectors, by several activities. In order for a transboundary destination to function, it is essential to establish trust and on-going cooperation between motivated and skilled individuals and organisations from each region, joining in the AoE destination.
